Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommend a vote FOR all the nominees listed, FOR Proposals 2 and 3, and for 1 YEAR on Proposal 4.

- To elect three Class III directors (Robert A. Frist, Jr.; Terry Allison Rappuhn; Frank E. Gordon) to hold office for a term of three (3) years and until
