HealthStream's annual meeting of shareholders will be held on May 26, 2022, at 2:00 p.m. (CT) in a virtual meeting format only, via live webcast at [meetnow.global/MKR7NWD](https://meetnow.global/MKR7NWD).

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommend a vote **FOR** all the nominees listed and **FOR** Proposals 2, 3 and 4.

1. To elect three Class I directors (Thompson S. Dent; William M. Stead, M.D.; and Deborah Taylor Tate) to hold office for a term of three (3) years and until their successors have been duly elected and qualified.
2. To ratify the appointment of Ernst & Young LLP as the Company's independent registered public accounting firm for the year ending December 31, 2022.
3. To approve, on an advisory basis, the compensation of the Company's named executive officers as described in the Company's proxy statement.
4. To approve the 2022 Omnibus Incentive Plan.
