

## HealthStream Acquires de'MEDICI Systems; Acquisition Adds Over 200 Hospital Customers, Bringing Total To More Than 1,000

The acquisition will be accounted for as an asset purchase. Revenues from the acquisition are expected to add approximately \$500,000 in 2001. Before the effects of depreciation and amortization, HealthStream expects that the acquisition will be accretive in 2001.

De'MEDICI Systems is a producer of interactive, computer-based training of healthcare education for healthcare organizations.
